Bylaw Proposed Change:

At our next general meeting on June 21st 2025, we will be voting on a By-Law Change:

Current Wording:

Article VII - Membership

Section IV – The membership waiting list shall be waived for one legal child of a member with ten years in good standing upon the submission of an application. A priority list will be established for these children when the Chairman of the Membership Committee receives the application. As openings become available, a membership will be offered alternately between the top name of the priority list and the top two names of the regular waiting list, unless there are more than 10 names on the priority list, then a membership will be offered alternately between the top name of the priority list and the top name of the regular waiting list until such a time as there are 10 or less names on the priority list.(remove) If the top name does not accept the invitation to join when asked, his/her name shall be removed from the list. Upon receipt of another application, with respective fees, that name will go to the bottom of its respective list. If a fully initiated member in good standing becomes deceased, a child under 18 years of age will have one year after his/her 18th birthday or a child over 18 will have one year from the date of death to make application for the priority list.

Proposed Change:

Article VII - Membership

Section IV – The membership waiting list shall be waived for one legal child of a member with ten years in good standing upon the submission of an application. A priority list will be established for these children when the Chairman of the Membership Committee receives the application. As openings become available, membership will be offered alternately between the top name on the priority list and the top two names on the regular waiting list. If the top name does not accept the invitation to join when asked, his/her name shall be removed from the list. Upon receipt of another application, with respective fees, that name will go to the bottom of its respective list. If a fully initiated member in good standing becomes deceased, and has not yet placed one legal child on the priority list, (clarify) a child under 18 years of age will have one year after his/her 18th birthday or a child over 18 will have one year from the date of death to make application for the priority list.

Rationale:

There was a time when our priority list was much shorter. We now have 17+ on the priority list and do not anticipate it going under 10 for some time. To be fair to those on the regular membership list and to quite honestly keep the process straightforward, it is proposed that we have a consistent process. Please keep in mind that members often have a child both on the priority waiting list and a child(ren) on the general membership waiting list. With this process, we hope to be fair to all members, their families, and our future members who have been waiting for, in some cases, 20+ years.
